### **Password**

### **Skip Public Wi-Fi**

If you ever use a public network, like a Wi-Fi hotspot in a coffee shop or anywhere else, be extremely careful. Treat this network as though every page you visit will be monitored, which may expose your personal information, including your usernames and passwords. It is best to do your online trading application from the security of a private home network. If you travel often and need to use online trading, consider choosing your mobile provider's data plan for online access.
